



## CONDITIONS OF REGISTRATION

### REGISTRATION

For a registration to be validated by A.S.O. (Amaury-Sport-Organisation) 40-42 Quai du Point du jour 92100 BOULOGNE-BILLANCOURT (hereinafter ASO) you must :

- Fill out your entry form on the rally's website: [www.andaluciarallyodc.com](http://www.andaluciarallyodc.com) ,
- Make the deposit, corresponding to the pre-commitment fees, and in respect to the payment schedule.
- Register all the requested documents by **April 30, 2021**.
- Be 18 years of age or older.
- Be in possession of a sports license corresponding to your category.
- Have proof of and be in possession of a valid driver's license appropriate to your vehicle. Documents attesting to the loss or theft of a driving license will not be accepted.
- Have the corresponding authorization from your National Motorcycle Federation (FMN) or your National Automobile Federation (FAN).
- The Organizing Committee reserves the right to refuse the registration of any team, member of a team or competitor.
- Registration will not be final **until the payment of the full registration fee has been made, at the latest, by 30<sup>th</sup> of April 2021**.

### DISCLAIMER OF LIABILITY

Each registered participant in the Andalucía Rally 2021 is fully aware of the risks involved in participating in a competition of this type. Each registered participant exonerates, from this moment on, the company AMAURY SPORT ORGANISATION, its representatives, employees, and/or any person acting on its behalf, the Organizers, the FEDERACIÓN ANDALUZA DE MOTOCICLISMO and the FEDERACIÓN ANDALUZA DE AUTOMOVILISMO, of all criminal or civil liability in the event of a physical or material accident as a result of participation in the Andalucía Rally 2021 and/or in case of damage occurring in the competition and/or to assistance vehicles.

## **REGISTRATION RIGHTS**

All participants wishing to enter the Andalucía Rally must pay the entry fees that will follow at the end of this document.

## **CONDITIONS OF CANCELLATION**

In case of not being able to participate due to the contraction of the COVID virus:

- In addition to Art. 4.6 (Car Regulations) and RP80.4/8.2 et RP80.4/9 (Bike / Quad Regulations), if one or the other of the following conditions or both are present:
  - Impossibility of boarding, disembarking and / or transportation of a Competitor and / or his Vehicle due to national and / or international transport restrictions of the country of origin of the Competitor and / or Assistance member and / or host country of the Rally due to COVID-19, and / or;
  - Impossibility for a Competitor and / or Assistance Member to start the Rally due to a positive PCR test for COVID-19, in accordance with the provisions of the health protocol established by the Organizer.
- If this situation happens, the registration fees paid to date to ASO will be, at the Competitor's choice:

- Reimbursed deducting the registration fees corresponding to € 350 (three hundred and fifty euros) for the race vehicles and 15% (fifteen percent) of the registration fees for the vehicles and assistance persons as dossier expenses.
  - Fully transferred as Registration Rights for the Rallye du Maroc 2021 or Dakar 2022, without deduction of administrative fees and without, however, this constituting an admission to the 2021 edition of the Morocco Rally or 2022 of the Dakar.
- No refund request will be accepted from the moment the Competitor and / or the Assistance member have been authorized to start after the administrative and technical checks.
  - The report of the inability to participate in the Rally due to COVID-19 must be sent by the Administrator, by email requesting reading confirmation from ASO, to avoid any dispute, in French, English or Spanish, to: [andaluciarally@aso.fr](mailto:andaluciarally@aso.fr)

## **PAYMENT**

The organization will accept only one payee per vehicle and/or per team. The payment must be made exclusively by bank transfer or credit card (sender must pay bank transfer fees). Please indicate the name of the team and your file number, including the reference Registration Andalucía Rally 2021, when making a bank transfer. **The total payment must be made before April 30<sup>th</sup> at the latest.**

## **BILLING**

A single invoice will be issued for the services offered by the Andalucía Rally, duly detailed at the address and name provided by the Team. In no case may different individuals or legal entities be billed for the same registration.

## **PROHIBITION TO START**

If as a result of the administrative and/or technical checks, a Team or vehicle is prohibited from starting the race, it cannot claim a refund of the amounts paid for any reason.

## **CANCELLATION OF EVENT**

In the event that the Andalucía Rally exit could not take place, for whatever reason, the Race Organizer would be responsible to the participants only for the payments received to date. No claim may be made against him for other reasons.

- Transferred in full to the new event dates in 2021, or under the registration fees for the 2021 Rally du Maroc or the 2022 Dakar, without deduction of the application fees and without this constituting any admission to the 2021 edition of the Rally of Morocco or 2022 of the Dakar;
- Fully refunded without deduction of administrative fees.

## **SECURITY EQUIPMENT**

### **GPS, Iritrack, Balise:**

The rental of this security equipment is not included in the entry fees (with the exception of the Enduro Cup) as well as the purchase of the fixture kits and accessories for this equipment. You must order them directly from the service providers (order forms are downloadable from the website).

It is imperative that the kits be installed before the start of technical checks and that the electrical connections be operational. For each piece of equipment, a deposit will be required at the time of the administrative checks by the service provider in order to guarantee restitution or repairs in the event of damage.

## **INSURANCE**

It is the responsibility of the participants to ensure that the insurance of their vehicle is valid in Spain.
