

STOP CORONAVIRUS

COVID PROTOCOL ANDALUCIA RALLY 2021

1. Preamble

This protocol is designed in compliance with FIA ISC Appendix S – Covid19 Code of Conduct, and serves as a “Covid-19 Mitigation Plan” according to the Code. In any case, local regulations prevail over this document. In case local regulations are amended, this Covid-19 shall be updated.

Rally-Raid, a motor sport discipline where the risk of COVID-19 infection is very limited, mainly because:

- It is an outdoor discipline, held entirely outdoors, on rural roads away from towns and urban areas.
- It is an individual sport, with no contact between participants, where the motorcycle rider and driver/co-driver circulate daily, isolated in their own vehicles.
- As it takes places on rural roads, in one direction and never through the same place, it is very difficult for the public to gather along the route.

The Andalucía Rally is a safe proposal, where the risk of contagion or transmission of the virus will be limited as much as possible, in order to protect at all times both the population where the event takes place, as well as the Rally caravan itself.

For this reason, we have implemented a series of strict and necessary sanitary measures prior to the celebration of the event that everyone (competitors, mechanical and assistance team, organization team, media, suppliers, service providers, authorities, etc.) must follow to be allowed participate in it.

Security will be our obsession and, in this sense, we have chosen a private estate, absolutely isolated and closed to the outside, with a single point of access, where the COVID Check

Point will be located, with 24-hour operation from the beginning of the assembly and installation of the infrastructure for the event, until the end of it.

We have chosen as a base for the event the **Hacienda El Rosalejo** (www.elrosalejo.com), located in the municipality of Villamartin (Cadiz), a 300ha country house 7 km. away from this town, which for 8 days will be an authentic Sanitary Bubble, with the strictest sanitary measures, those which stand out are:

- It will be **mandatory** to present a **negative COVID19 RT-PCR test less than 3 days old** (72 hours) (the third day being the day of arrival in Spanish territory for foreigners). The ORIGINAL document accrediting this test must be presented at the **COVID Check Point** installed at the only possible entrance to Hacienda El Rosalejo, before entering it for the first time, after which each person will be identified by a "COVID Bracelet" which will be the only thing that authorizes any person entry to the site (participant, mechanic, assistance, organization, press, authorities, suppliers, site staff, etc.).
- **The catering services** (breakfast, lunch and dinner) for the entire group will be provided **within the enclosed site** of Hacienda El Rosalejo, directly by the Hacienda staff, with strict daily hygiene control and specific protocol of catering establishments, among which we point out:
 - Self-service prohibited
 - Mandatory entrance and exit circuits to and from the restaurant area.
 - Mandatory pass-through and directional circuits
 - Individually wrapped cutlery, tableware, dishes, table linens and single-use utensils
 - Adequate hydro alcoholic gel in each unit.
 - Preferential outdoor dining area
 - Body temperature of each person entering the catering area will be taken at the time of each entry.
- **A special supermarket** will be set up, with personal hygiene products, food, disinfection products, etc., available to all participants, to avoid the necessity of leaving the hacienda and coming into contact with the general population.
- This is a **closed-door event**, without spectators, with secret routes to prevent the public from accessing the stages.
- **The base of the event will be totally enclosed**, access without COVID Check accreditation is strictly forbidden.
- **Reduction of the personnel involved in the Organization** and within the competing teams, to avoid risk and ensure the safety of the event, doing everything possible at a safe distance, and where it is not possible, with the maximum anti-contagion guarantees (double mask/mask + screen, etc.)

- **Accommodation in a selection of hotels reserved exclusively for participants** in the Rally, prohibiting travel by general public transport, for which a **private transfer service** hotel/paddock/hotel is offered to participating teams, Organization and Media personnel.
- **Specific COVID signage and posters** with clear and strict hygiene and safety instructions for the different players, with the aim of limiting contact between groups and strict proactive surveillance throughout the event. To this end, we created our own **COVID monitoring and surveillance team**, with stewards who will ensure strict compliance with all these measures.
- Implementation of a **COVID-specific Occupational Risk Prevention** system to minimize risk during the event.
- **Comprehensive "BUBBLE"** management of the entire general group, with the establishment of sub-groups and dependent groups, functioning in "internal mini-bubbles", in order to protect the members of each group, regulate the interaction between sub-groups and facilitate risk control by sectors, making it easier to manage any incident, traceability or traceability of each process.
- Implementation of a complete **Contagion Health Protocol**, which includes random control tests, PCR or serological tests in the event of possible positives, health care procedure, isolation and contact tracing, following the procedure established by the SAS and the Health Authorities of the JJAA and guaranteeing the sanitary quarantine in its case.
- Complete adaptation of our Protocol, to the regulations and recommendations of the **WHO, Ministry of Health, CSD, Auto and Moto Federations and Ministry of Health and Families of the JJAA**, especially in procedures, treatment guidelines and action items.

2. Event description

It is an All-Terrain Rally, which will be held without public attendance and with Base and Paddock behind closed doors, with the participation of athletes of various nationalities.

- **The dates of the Andalucía Rally:**
 - o 10th May at 14H00: Opening of the bivouac to all competitors
 - o 11th and 12th May: opening of administrative and technical checks (scrutineering) and Prologue 12th afternoon.
 - o 13th to 16th May: Stage 1 to Stage 4 of the Andalucía Rally

- o 16th May: departure of rally caravan from the bivouac.

- **Andalucía Rally features:**

- o 800 pax in total: competitors, team staff, organization staff, officials, service providers, media, partners and guests.
- o 200 ground vehicles in total, competitors, team staff, organization staff.
- o A specifically designed caravan: a checkpoint at the entrance of the Paddock to achieve a bubble as airtight as possible to Covid19.

3. Strict rules that must be complied with in the Rally

General principle: the application of systematic barriers for all persons involved in the Rally, in all areas from the arrival in the Paddock until the end of the event.

Compulsory presentation of a negative PCR test before entering the Paddock.

**Fundamental principles: «the people involved» = pilots / co-pilots, staff, organizational team, officers, doctors, suppliers, media, associates, guests and exhibitors.*

- **Use of masks is mandatory in all spaces.**

- o Good practices reminder: how to put on /take off / dispose of the mask, duration of effectiveness, the need to change the mask every 4 hours / or as soon as the mask is wet.
- o Obligation for everyone coming to the Rally to bring a sufficient number of masks. For example: 5 masks per day for single use x 8 days, about 40-60 single use masks.
- o Upon departure as well as on Spanish territory.
- o In the bivouac in all public areas: reception, checks, briefing, press conference, interview areas, awards ceremony, access to catering, sanitary areas, etc.
- o In the bivouac, including in the teams' private spaces when the physical distance of 1.5 m is not possible.
- o Driver / co-driver(s) outside the race, after an incident: at the exit of their vehicle after removing the helmet and in the presence of the organizing teams (medical assistance).

- **Hand hygiene:**

- o Reminder of good practices: wash your hands several times a day, after each contact with a person or being in contact with a surface susceptible of being touched by a large number of people (for example: vehicles (door handles, steering wheels, controls, etc.), material for collective use (certain tools, when

- possible each person should have their own hand tools, photocopier, printer, coffee maker, etc.).
- Self-service hydro alcoholic gel available at all key points in public areas: administrative and technical checks, information sessions or briefing, press conference, interview areas, awards ceremony, access to restaurant and sanitary areas.
 - It is mandatory to carry a bottle of hydro alcoholic gel at all times.
 - Possibility of buying hydro alcoholic gel at the bivouac.
- **Respiratory Hygiene /good practice reminders:**
 - Cough / sneeze into your elbow and away from other people.
 - Use tissues to blow your nose and for any spittle.
 - Do not spit on the ground.
 - Wash your hands after throwing away the tissue.
 - **Limit physical contact:** no handshakes, hugs, kisses, etc.
 - **Wear a protective visor in addition to the mask in the following circumstances:**
 - When you cannot ensure the 1.5m distances due to the nature of the work: for example, some mechanical tasks within the same team require close collaboration.
 - At certain times, when people must carry out an exchange while respecting the physical distance of 1.5 m, with a large number of people and for a significant total duration: for example, the people working in the organization at the reception point during the administrative and technical checks in the bivouac, to the officials and members of the organization in the CH (Time Control) in charge of delivering the Time Cards to the pilots.
 - The journalists giving the interviews, for all types of interviews (press conference, arrival of the specials, etc.), respecting the physical distance of 1.5m to protect the people being interviewed (pilots, co-drivers, personalities, etc.)
 - **Use of your own equipment and material as much as possible:**
 - Each person must have his or her own equipment and not lend it to another person.
 - Personal material in question: administrative (paper, pen), office material (telephone, laptop), and (hand tools, radio, etc.).
 - Reminder of the obligation to disinfect personal equipment twice a day.

- **Procedure for the use of collective material:**
 - Type of material: bureaucratic (photocopier, printer, etc.), technical (radios with the need to recharge at the end of the day in a collective charger, tools), vehicle, TPE, etc.
 - Wash your hands before using the material.
 - Mandatory material disinfection (printer and copier keyboards)
 - Mandatory to wash your hands after using the material.
- **Frequent cleaning of the different spaces in the bivouac:**
 - Toilets: Several times a day.
 - Dining area: cleaning of tables after each use.
 - Workspace (organization area, media, health area, Race Control Point (PC) etc.) 2 times a day (late morning and afternoon)
- **Signposting as a reminder of anti-covid measures located in key points in public spaces**
 - The key points: reception at the bivouac, administrative and technical checks, outdoor areas, press-room, interview area, award ceremony, dining areas and sanitary spaces.
 - Signposting based on the WHO recommendations and signage with messages written in Spanish and English.
- **Materialization / Signage to facilitate physical distancing in the bivouac:**
 - Direction of entry/exit in key locations: bivouac parking, in the bivouac, in the dining area, accommodation and sanitary facilities.
 - In high-traffic public spaces with possible interactions between different groups, marking of the different areas on the ground to respect the physical distance of 1.5 m, although the use of masks in crowded public spaces is mandatory: at administrative and technical checks, press conferences, information sessions and briefing, at the arrival point, on the podium, and at the awards ceremony.
- **Management of the dining space by groups / subgroups and establishment of time slots to make traffic as fluid as possible and limit queues.**
- **Limitation to use of physical documents, optimized use of digital documents:**
 - Elimination of the official information panels to avoid crowds of people in a particular space: for example, sending online information announcing the availability of the results on the website.
 - Limiting the publication of documents (timing, etc.) to the minimum for the different groups (for example: sports organization, starting list, road book in paper format), distribution of information by digital means.

- **Multiple information supports as a reminder of good practices reiterating the message:**
 - Reminder of their obligations within the regulations, with the annex title "Covid19 Protocol" as well as in different materials (posts on the website and the official social networks of the event, direct information to the contestants by email)
 - Information and data sheet of the participants integrating the outcome of the final results of the Covid19 RT-PCR test.
 - Integration of the various provisions within the event's safety plan, on the schemes and diagrams, job descriptions and different official roles, the road book, and the accident management plan.
 - Monitoring by the COVID19 team made up of a reference person and several members of the organization's team: a friendly reminder in case of non-compliance on the first occasion, exclusion of the person, regardless of their function (pilot, team member, organization, official, media, partner and guest), in the case of failure to take the first reminder into account with repeated non-compliance.

4. Risk prevention and Risk management procedure for COVID19 during the event

Processing of COVID19 medical data:

- The data concerned, coming from a Covid19 test of less than 3 days (72 hours) and the Covid19 evaluation questionnaire collected by the organization's doctors.
- The tests will not be the object of any dissemination other than the one that the organization's doctors must do in the exercise of their profession (tracking of infected people, liaison with the health services of the Region, etc.).
- The organization will provide a covid19 report post-event, with statistical and non-nominal data.
- All data that has been disseminated in the medical context described above will be destroyed 14 days after the end of the Rally, the 30th of May 2021.

Precursory information, awareness of the assembly of people involved

- Description of the complete Covid19 prevention system in the appendix to the specific regulations "Anti-covid19 system", meaning that, the guidelines will apply to all people present at the bivouac. This document will be considered finalized upon validation by the authorities and will explicitly stipulate that any offender who exposes themselves and others to a health risk:
 - Will be excluded from the bivouac and from the event, and, if you are a pilot, it may entail a risk of disqualification.
 - Represents a risk for the continuation of the Rally.
- Ensure that the various people remain confined to the extent possible, scrupulously respect the regulations of the Rally and do not leave in case of a positive test.
- A negative Covid19 test of less than 3 days (72 hours) is essential to enter the Spanish territory and the bivouac.
- The obligation to bring your own material to respect the regulations during the trip and the event (see point 3), the list that is mentioned in the document "Anti-covid19 system":
 - Masks: 50 masks minimum for people participating in the Rally. 80 masks minimum for people attending the rally and the week of testing.
 - Bottles of hydro alcoholic gel in packs that allow you to always have a bottle at night.
 - Tissue paper

- Products to disinfect materials and equipment, based on a 70% alcoholic solution or other disinfectant products with a bleach base.
- Reminder: if necessary, it will be possible to buy products at the bivouac.

Upon arrival at the bivouac

We can distinguish 2 types of flows:

- Flows from outside Spain.
- Flows from Spain
 - The Spanish service providers involved in the Rally at an organizational level.
 - The Spanish media
 - Representatives of partners, authorities and guests.

In all cases, and for the bivouac to be a negative COVID 19 zone, the same conditions apply to those who wish to access the bivouac later or on their own:

- Negative COVID 19 test of less than 3 days (72 hours)
- Possession of personal materials (masks, hydro alcoholic gel, disinfectant products) based on people's roles within the rally and appropriate protocol (physical distancing, respiratory hygiene) to be able to respect the regulations.

Anyone staying at the bivouac must have a COVID bracelet provided by the organization, as well as an "accreditation" bracelet. The COVID bracelet will be given at the control point of the entrance to the bivouac, only with previous presentation of a negative COVID test.

Differentiated group strategy:

A strategy recommended by the WHO and the international sports bodies of the FIA and FIM to limit as much as possible the risk of spread in the case of persons affected by COVID19:

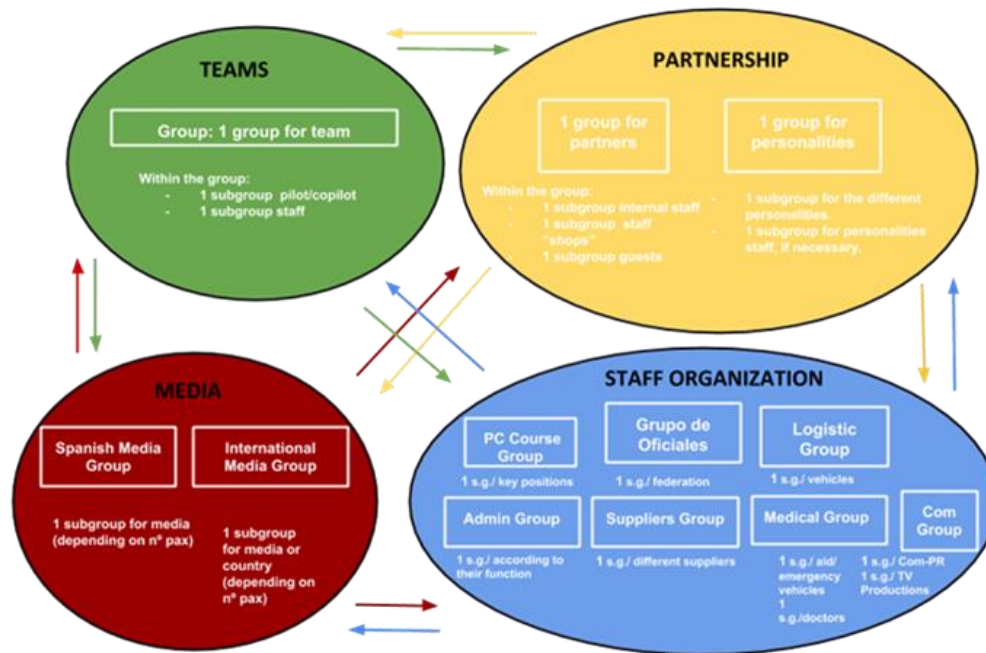
- Identification of bubbles, groups making up each bubble and sub-group by function
- Limit contact between bubbles/groups as well as contact within the same groups between sub-groups by function.
- Assign private spaces to bubbles/groups/sub-groups) as much as possible:
 - Workspace: space for each team of 5m among each other, organization tents assigned to each group / subgroups.
 - Accommodation: tents accommodating people from the same subgroup.
 - Catering: people in the same group / subgroup eat their meals together. Slots will be established to reduce queues and people flow.
 - Limit the interaction between the bubbles, groups / sub-groups to ensure proper functioning of the event (security, sport, promotion, media...).

- The key moments with interaction between bubbles/groups/sub-groups are considered as being the riskiest and therefore are the subject of reinforced provisions (see point 3).
- Apart from these key moments, the organization incites the members of the same group (for example, a team) to stay in this same circle and not to visit the members of another group (for example, another team), if this is not for an essential reason and in a limited way.

The benefits of the strategy

- **Easy tracing:**
 - Easier identification of different spaces and times.
 - Limited number of contacts.
- **In the event of a positive Covid19 case:**
 - Limited number of people to isolate and test.
 - A risk that is all the more limited within the same group/sub-group as each member must respect the regulations outlined in point 3.

5. Specific COVID medical procedure, treatment guidelines and risk prevention action items.

Our commitment and vigilance will be to carry out this sporting event in the safest possible way, observing all the recommendations of the WHO, Ministry of Health and the Ministry of Health and Families of the Andalusian Regional Government, pillars in the preparation of this protocol.

ANTI-COVID ACTION PLAN FOR THE ANDALUCÍA RALLY.

5.1. ONE LOCATION ONLY AND OUTSIDE AWAY FROM URBAN AREAS

The headquarter that will host the Andalucía Rally will be unique, the same for all people who in one way or another are linked to the race: competitors, journalists, staff, etc., and will be outside the urban environment, in the estate "Hacienda El Rosalejo", in Villamartin (Cadiz), which will undoubtedly facilitate access control and allow us to create "a bubble" of surveillance and close monitoring of all staff.

5.2. PCRs PRIOR TO THE RALLY AND RESPONSIBLE DECLARATION.

Prior to access to the bubble, a negative PCR will be required to all competitors involved in the Andalucía Rally as well as the rest of the members of their team. This PCR test must have been done no later than 72 hours before access to the aforementioned rally venue.

Those who do not present it will be excluded until they do so.

Likewise, each person must submit with his/her PCR a signed responsible declaration stating that he/she does not suffer from symptoms compatible with covid, and that the appearance of any of these symptoms will be promptly reported to the rally's anti-covid staff, as well as that he/she will always comply with the requirements of such staff and follow their recommendations.

Similarly, the person must indicate if he/she has already contracted and overcome the disease (resolved infection), only if the contraction of the virus has occurred within the 90 days prior to May 16- end of the Andalucía Rally 2021, providing the relevant documentation to prove and verify this fact.

Also, in this declaration he/she will commit himself/herself to follow the general recommendations of mask use, hand hygiene and social distancing, as well as to keep a daily control of the persons with whom he/she lives or interacts in order to facilitate a tracing if necessary.

***If any of the persons related to the rally has already overcome the disease, they must provide a corroborating medical report in accordance with the indications of the Ministry of Health.

5.3. TEMPERATURE CONTROL

During the verifications of the rally and when the PCR tests and the responsible declaration are handed in, the temperature of each individual will be taken.

Likewise, each day that access is granted at the entrance to the Rally venue, the temperature of each individual will also be taken.

A temperature equal or higher than 37.5 at rest will lead to a physical examination and interview with the individual in an isolated room and will be communicated to the health authority designated by the Board.

5.4. IDENTIFICATION AND CONTROL OF THE PERSONNEL LINKED TO THE RALLY.

Once the corresponding PCRs, the responsible declaration and the temperature taking have been presented, a bracelet will be placed on the wrist of each individual who presented the test.

This bracelet will be of obligatory use during the entire sporting event and will allow access to the Rally venue, preventing entry to those who do not wear it. It will also be shown whenever required by health and security personnel.

5.5. BUBBLE COHABITATION

The same conditions mentioned above will apply to the kitchen and catering staff, as we will have a dining room at the rally headquarters or camp, always with the same staff and so that participants, staff or journalists do not have to leave the premises for anything, carrying out the strategy of staff "bubble".

The dining room will also enforce all rules concerning hygiene, one-way corridors, distance between diners and tables, contact groups, no self-service, etc.

5.6. SUSPECTED COVID CASE

Following the recommendations of the health authorities, in the possible presence of a suspected case, we will automatically proceed to isolate it and its nearby environment, which we will trace ourselves.

Immediately we will inform, through the anti-covid coordinator, the designated health authority by the Junta de Andalucía, will give us the indications regarding the health facility or hospital to which we will transfer the individual to perform the corresponding PCR Test in order to confirm or rule out such infection, transfers will always be done in the company of one of the health members of the anti-covid team of the rally, meanwhile keeping the

close environment of the suspected individual in isolation.

In the event that both tests are negative, according to the protocol of the Ministry of Health the case will be considered a "Discarded Case".

5.7. CONFIRMED CASE

In case of a positive PCR Test or a positive IgM, we will have a "confirmed case", which will remain isolated for the time established in the protocols, 14 days, as well as its close environment, without prejudice, that all of them will take the corresponding PCR test in a location designated by the health authority.

5.8. ISOLATION

In the case of isolation being required for any person linked to the rally, this will be done in a hotel or possible a rural house with single rooms, that the Organization will rent in its entirety, being reserved exclusively for this purpose, and the organization itself will be responsible for the care, observation and control of patients, as well as monitoring compliance with all health standards and communication with the health authority designated through the coordinator of the anti-covid team of the rally.

If the patient requires hospital admission, this will be done following the advice of the health authority designated by the Andalusian Board.

ANTI-COVID TEAM ANDALUCÍA RALLY

The "anti-covid" team will be formed by 3-4 health professionals with experience in the fight against this pandemic and will have a coordinator who will be responsible for being in close contact with the health authority determined by the Andalusian Board.

Dr. Dario Rodriguez Morales, anti-covid coordinator in the Andalucía Rally, will exercise this function of coordinator.

5.9. ANTI-COVID TEAM FUNCTIONS

These functions will be in force during the entirety of the rally:

- Observation of scrupulous compliance with the anti-covid protocols of the Ministry of Health and the Junta de Andalucía during the rally in relation to signaling, use of masks, washing and hand hygiene, social distance, dining room, etc ..., ensuring to comply at all times with the current regulations.
- Routine and constant surveillance of all personnel involved in the race.
- Taking the temperature of all individuals entering the enclosure and recording it.
- Transfer of possible cases to the hospital or where determined.
- Verification and control of isolation to be dictated if necessary.
- Care and assistance of isolated patients or confirmed cases

- Health information and training.
- Custody of all health reports and statements provided strictly keeping its secrecy and confidentiality.

This team will be in close contact with the health team designated to attend to any further incidences that may arise during the race, they will be differentiated by means of distinctive badges, perfectly recognizable by all and will be a permanent physical presence 24 hours a day at the rally headquarters-camp.

This particular Anti-COVID19 Protocol is complementary to the General Protocol for federated motor sports competitions, approved by the Ministry of Education and Sports of the Junta de Andalucía on July 11, 2020, according to the favorable visa of the Ministry of Health and Families of the Junta de Andalucía on July 10, 2020.

RESPONSIBLE STATEMENT AND INFORMED CONSENT CLAUSE

Reading, understanding and acceptance of this document is an essential condition to take in the ANDALUCIA RALLY 2021.

As a participant in the ANDALUCIA RALLY 2021, you declare that:

1. That you are aware of the security measures and the COVID-19 Protocol, proposed by the Organization for participation in this event.
2. That you undertake to comply with the guidelines or follow the recommendations issued for the event, as well as the instructions given by the sports authorities or Organization staff present at the competition in relation to the measures to avoid contagion by COVID-19.
3. That you undertake not to attend or take part in the event or competition in the event that he suffers from symptoms that could be compatible with the spread of COVID-19. This will also be extended to cases in which the symptoms were suffered by third parties with whom the participant has or has had a contact from which, objectively, a contagion could be derived.
4. That, if you become aware of being affected by the COVID-19 virus, you undertake not to attend or take part in the event or competition as long as the Health Authorities do not state that participation does not entail a risk, either for his person, well for the rest of the assistants with whom he could have contact.
5. That, with the means at their fingertips, and in any case when there have been circumstances that make it advisable, they have undergone the existing tests to check if they are or have been infected by COVID-19 and contribute to the Health Services of the Organization, negative COVID-19 test with a completion date of less than 72 hours upon arrival at the event.
6. That you acknowledge, accept and assume that, in the current state, there is an objective risk of contagion of COVID-19 with the consequences that could derive from it for your person in terms of health or problems that could even cause death and therefore exempts the Organization of the event from any type of responsibility for this circumstance.
7. That you accept that the Organizer of the event adopt the measures indicated in his document / protocol / guide that he has published in order to establish a reasonable safety scenario in the competition. In this sense, it is stated that the Organizer of the event, in the course of the activity or competition, may adopt the measures or decisions that are necessary in relation to the establishment or application of the measures contained in this published document or any others whose purpose was to provide the race with a safe environment in terms of avoiding COVID-19 infections.
8. That, if you get infected by COVID-19 during the event, you exonerate the Organizer of the event and the Automobile and Motorcycling Federations that approve the Sporting Regulations of the event, from any responsibility in relation to the possible damages or losses that may arise for His person.
9. That you accept that if some measures or decisions need to be taken by the Event Organizer with the aim of preserving the health of people during the course of the

- competition, the obligations contracted will not be considered as broken. Therefore, the payment of amounts, compensation or refund of prices or amounts for registration or participation rights or costs incurred by the pilot and / or his club may not be required.
10. That you accept that if you show a conduct or behavior of non-observance or non-compliance with the orders and instructions of the Organization's staff in relation to the security measures to avoid contagion by COVID-19, it may be subject to exclusion or disqualification of the event by decision of the person who acts as the Competition Jury.
 11. That you accept that the sporting measures set out in the previous section are understood without prejudice to other responsibilities that he or she may assume before the competent authorities (including federative disciplinary committees) as a result of conduct or behavior of non-observance or failure to comply with the orders and instructions that are applicable, either in the sports-federative field, or in other different fields.
